MacBook Air devices are available for lease at \$25.50 each month per device (if enrolled in FACTS) or annual or semi annual payments of \$127.50 or \$255.00. Accidental damage insurance may also be purchased within 24 hours of taking possession of the MacBook Air for \$100.00 and will cover one instance of theft, loss, or hardware replacement for the 2017/18 school year.

TERMS & CONDITIONS

I understand that I will be responsible for monthly lease payments (\$25.50 per device). Payments will be set up using FACTS or can be paid annually or semi annually.

My student will pick up the MacBook Air during the first week of school.

I have read the MacBook Air Lease Agreement on the reverse side of this page and agree to abide by the terms and conditions herein. Specifically, I acknowledge that the MacBook Air remains the property of Carlisle School. If I decide to terminate the lease, I am required to return the MacBook Air to Carlisle School in good working condition.

MacBook Air Lease Agreement: Carlisle School

The term "MacBook Air" shall include the computer, cords, case, and any other devices included with original packaging.

The TERM of the lease is one year; however, it may be terminated at any time per the written request of the parent. During the term of the lease, the MacBook Air remains the property of Carlisle School. An optional insurance policy is available as outlined below. Carlisle School reserves the right to terminate this lease at any time and require the return of the MacBook Air.

During the term of the lease, if a student is not enrolled at Carlisle School for any reason, he/she must return the MacBook Air to the school. If Carlisle School does not receive the MacBook Air, the full price of the device will be charged to the student's account. Returned MacBook Airs must be in good working condition.

CARE OF MACBOOK AIR

Each student is responsible for keeping the leased MacBook Air in good working condition. If repairs are necessary, the MacBook Air must be turned in to the Carlisle School IT Department. Families without MacBook Air insurance will be billed for any needed repairs.

INSURANCE

An optional insurance policy is available for purchase for \$100 per MacBook Air device. The insurance will cover any accidental damage and one (1) instance of theft or loss of a device. I understand that if I do not elect to purchase the insurance that I will be liable for any damage sustained by the device and will be required to pay for any repairs up to and including full replacement cost if needed. I understand that I will be liable for the full replacement cost for any non-insured device that is lost, stolen or not returned at the end of the lease. Families who wish to purchase this policy must do so

within 24 hours of taking possession of the device. They must sign a contract and will have the option of sending with it a \$100 payment or permission to charge \$100 to the September FACTS billing.

DEFAULT

A student shall be deemed to be in default under this MacBook Air Lease Agreement upon the occurrence of any of the following events: a) the student fails to pay any amount when due under this Agreement; b) the student subleases, assigns, or makes any transfer of the MacBook Air; c) the student fails to perform any obligations or violates any terms of this Agreement.

Carlisle School shall have the right in its sole discretion upon a default to direct the matter to Carlisle School's choice of collection agencies, in which case all reasonable costs and expenses, including reasonable attorney fees, incurred in connection with enforcing the terms, conditions, or provisions of this agreement shall be recovered from the student and/or the parent/guardian.

PAYMENT AND RESPONSIBILITY

I understand that I will be responsible for all lease payments depending on total number of months leased. If I am enrolled to make monthly tuition payments through FACTS, The first month's lease payment of \$25.00 will accompany this signed agreement. Thereafter, each month's payment will be charged to my student account at the beginning of the month (September - May). Upon distribution of the MacBook, the student agrees to sign a receipt which shall record the MacBook model, serial number, and conditions of the equipment.
